Dear Asst. Sec. James, Lt. Gen. Semonite, Brig. Gen. Holland, and Col. Clark:

I am writing to respectfully request that you direct unallocated fiscal year 2018 funding to two maintenance dredging projects in Dare County, North Carolina – Oregon Inlet (Manteo – Shallowbag Bay) and Hatteras Inlet (Rollinson Channel).

Our offices have discussed these projects at length on countless occasions. I know you are aware of the chronically poor navigation conditions at both inlets. I am grateful these projects were included in the president's fiscal year 2018 budget request. The amounts provided – \$4,790,000 for Oregon Inlet and \$1,000,000 for Hatteras Inlet – were encouraging. Unfortunately, they may not be sufficient to keep the channels maintained at their authorized depths.

As you know, due to the ban on congressional earmarks, North Carolina's senators and I have no ability to add money to these specific projects through the legislative process. However, to address situations such as these, Congress added to the Corps' fiscal year 2018 appropriations bill several unallocated pots of money for different project categories. For example, \$24.28 million was added for "Navigation Maintenance," and \$50 million was added for "Small, Remote, or Subsistence Navigation." Oregon Inlet and Hatteras Inlet should be eligible for funding from either of these pots.

Congress also directed the Corps to consider several criteria when deciding which projects to fund from these pots. Both projects should rank highly based on those criteria. In particular, I would point out that the Coast Guard depends on access through these two inlets to execute their search and rescue, law enforcement and national security functions for hundreds of miles off the North Carolina coast. I would also emphasize that these two inlets are critical pieces of the economy in Dare and Hyde County, North Carolina.

I believe Oregon Inlet and Hatteras Inlet are exactly the type of projects that Congress had in mind when it provided the Corps with these additional pots of fiscal year 2018 funding. I urge you to give them all due consideration.
